Victoria High School Stadium Revitalization Project

Community Consultation Sessions and On-line Responses

1 Foreword

This report reviews the results of three community consultation meetings and the on-line survey that was part of that consultation process. This consultation process was conducted to inform the Fernwood community about the outlines of the Stadium Revitalization Project, and to seek feedback and suggestions from the community.

The three community open houses were held on October 28th, November 19th and December 2nd 2014. To encourage broad participation in the consultation, students from Victoria High School passed out leaflets to homes and businesses in the surrounding area – a five-block radius and beyond. Community associations and groups were informed of the meetings, and information about the topics to be discussed as well as the dates and locations of the meetings were posted on both the school and the Vic High Alumni Associations' websites.

Some one hundred people (57 at the first meeting, 27 at the second and 23 at the third) attended over the three evenings.

To encourage participation in the on-line survey, it was discussed at each of the community consultation sessions. In addition, the pamphlets students delivered also encouraged on-line feedback from households near the school. The on-line survey was hosted and highlighted on the Victoria High School website.

A total of 156 people filled out the questionnaire¹ between early November and mid January, although almost all of the responses were provided by mid-December.

2 The Community Consultation Meetings

All the meetings were held in the Vic High auditorium and were introduced with an overview of the proposals and a discussion of the phasing of the project. This was followed by the heart of the meetings: the opportunity for participants to ask questions and to express their reactions, support or concerns with the project.

The feedback from the public was very encouraging. Even for people who had some concerns or questions about the project, there was a generally shared view that this would be a very real asset

for the community. For some, the need for better athletic facilities was seen in broader terms as including providing greater opportunities for schools in the Vic High family. Many of them were seen to lack the facilities available to students from more affluent parts of the school district.

Many non-school sports groups and associations attended the open house sessions to let the panel know they were excited about the project. The groups who participated in the sessions included:

- Bays United Soccer
- Fernwood Football Association
- James Bay Athletic Association
- Victoria Track and Field
- Victoria Field Hockey
- Castaways Soccer Club

All these organizations indicated they could make excellent use of such a facility and said they would help raise funds. Each had specific examples of how the facility would serve the community and its own members.

Through these meetings, reflected as well in the survey responses, a number of topics were discussed frequently. These topics will be discussed in turn.

2.1 The Need for the Facility

While the sports groups all spoke of the need for the facility and the use which they and their members would make of it, there was wide agreement that the community, particularly its young people, did not have sufficient access to sports fields. While driving children to sports programs in suburban areas of Victoria was possible for some, other families found this a burden.

The need for such a facility was reflected in wide-spread desire that access to the field not be tied up fully by the school (although all shared the view that Vic High use was the priority) and the major organized sports clubs – many wanted to ensure that informal local groups could also use the field. This clearly reflects the scarcity of local fields that the community can use, both formally and informally.

2.2 Environmental Awareness

The plans showed the removal of some existing trees (Lombardy Poplars on the south end of the current field) and some of the participants expressed their concern about the neighbourhood losing trees. This was discussed in the meetings and two points were made in response. First, City of Victoria by-laws currently require two trees to be planted to replace any tree that is removed. Secondly, the trees which will need to be replaced have neared their life expectancey.

Some participants felt that trees and a turf field produce environmental benefits as they 'cleanse the air.' While this met with general agreement, others pointed out that having an articial field meant that more use could be made of the field, especially through the winter months, and that maintenance would be easier. For a few people who liked using a turf field for their dogs, it was pointed out that there were extensive grassed areas on other parts of the school property that might suffice.

While priorities differed on the question of turf versus articial field, it was clear that both the environmental impact and the need for year-round use had to be taken into account in the planning.

2.3 Design that is Sympathetic with the Neighbourhood and School

There were a number of different aspect of this issue that came up in both the meetings and survey responses. Participants sometimes expressed this with questions about the scale, particularly the height, of the facility and mentioned their desire to see something that fit with the neighbourhood. Some also mentioned the historic nature of Vic High's design and wanted a facility that did not detract from the school building.

Other participants, particularly those who answered the survey, mentioned that the stadium was originally built after World War II to honour veterans and wanted to ensure that link with the past and the veterans was respected. Still others mentioned that the project should be consistent with the openness and diversity of the Fernwood community.

2.3.1 Lighting

There were a number of questions about lighting, both its need for use in the winter season, and concern about potential effects on nearby neighbours. There was significant discussion about how those concerns could be taken into account in the design and placement of lights. As well, there was discussion about newer lighting technologies which are more focussed and efficient and have less impact or "spillage" on surrounding areas. The proponents committed to keeping these concerns in mind as the planning proceeded.

2.3.2 Personal Security

A number of residents mentioned that enhanced lighting in the area would increase their feeling of security at night as they walked and used the space around Vic High. This was particularly important to some of the women who participated in the process.

This focus on personal security also manifested itself in other ways during the discussions. Specifically, some wanted to ensure that the venue was secured when not in use so that it did not become a magnet for drug use or others who might make people concerned about their safety. Although not addressed directly in this context, there is some tension between these concerns and the desire of some others to have the facility as open and accessible as possible for informal use.

2.3.3 Parking and Traffic

Some respondents wanted to hear about traffic and parking related to the venue. They wanted to learn about the effects to ensure that there were minimal traffic and parking problems.

In response the proponents mentioned a number of things:

- Areas for staff parking would be shared with the community for evening events.
- The facility was being designed more as a practice facility than as a large event venue.
- For larger events like school competitions, buses couuld be used.

In addition, a few people said that more available parking might be helpful for The Belfry and some of the small businesses in the immediate area.

2.4 Management and Use of the Facility

In the public meetings, there were questions about ensuring that there were easily understandable and fair mechanisms for ensuring that the facility would be available to formal and informal groups who would want to use it. Survey respondents were even stronger in their view that building the facility was only the first step – it was equally important to think about maintenance and ensuring equitable access.


These topics are, frankly, quite sophisticated and show that those who commented on the proposal had thought through many of the practical consequences and brought their experience with other athletic facilities to bear in the conversations.

The proponents acknowledged and indeed welcomed this recognition of the importance of thinking past the construction to the management and maintenance. They talked about the requirement to have the school board and the city government agree on a use model that would meet these ongoing needs.

3 The Survey Responses from the Community

As described earlier a survey was the complement to the meetings. After a brief introduction, the survey began by asking "Should upgrades to the Victoria High School playing fields and sports facilities be a priority for the school? The responses were strongly in favour of the stadium upgrades being a priority for the school as shown in Table 1.

Only 12 people took the opportunity to add comments to this question; however, three themes emerge, each exemplified in the following comments:

- "As a school that is an integral part of a unique community, the two should be working together to improve Fernwood."
- "The school is home to Memorial Stadium, a unique facility within the school district.
 Unfortunately the facility is in a state of serious disrepair and the field has seriously deteriorated over the years with the lack of funding for maintenance."
- "Vic High is an arts and theatre school. Put the money into improved art and theatre facilities."


While the first two themes – the importance of Vic High's facilities to the community, and the sorry state of the current track and field facilities – recur through the survey, the concern that the stadium not take away from funding of other aspects of the school is also important. In its general form it was exemplified the the comment "I was amazed at how run down the school and

classrooms are. Upgrades to the school should be the # 1 priority." Just under five percent of the respondents expressed this concern, and they were consistent in making this point in response to virtually every question. Although this is a minority response, it is an important one that is a source of concern for some students.

To allay concerns, current students need to understand the funding situation and be assured that the facility will, in no way, detract from the school's operational funding.

The second question asked "Would a revitalized Victoria High School stadium facility create a better experience for current and future students?" The answers to this question were even more supportive of the project than for the first question.

Once again, although there was an opportunity to comment, only a few respondents availed themselves of the opportunity. The few comments reflected both support "Upgrades have been made to the buildings, so stadium should follow," and an implicit desire that the revitalization should not detract from other aspects of the school. This latter point exemplified by "I know that

it is a chicken and egg situation, but students don't come to Vic High for sports, they come for the cultural richness."

Respondents were asked whether they "would make a financial contribution to this project?" a plurality (38%) said that yes they would contribute; 25% said no, while 36% said they were not sure.

In many ways the most important questions were the three open-ended questions that sought more detailed responses from the respondents. This gave the respondents the opportunity to express their hopes, concerns and suggestions related to the revitalization without being bound to pre-set answer categories.

The following pages show the verbatim responses of ALL the respondents to the following three questions:

- 1. What changes would you like to see to the VHS Memorial Stadium?
- 2. What changes would you NOT like to see to the VHS Memorial Stadium?
- 3. How can community use of any new sports facilities be accommodated?

The responses have been arranged by broad category within each question. This is only a general and imperfect sorting (for example, many of the responses mention different topics and could have been assigned to multiple categories); however, it should help in understanding the scope of responses and the depth of interest shown by many who filled out the questionnaire.

In looking over the responses, we are struck by the care put into many of them. It is clear that people have thought about ways in which the revitalized stadium could best serve both the school and the community. Many have somewhat different preferences for the stadium, but they do share a commitment to seeing that the community and the school are both well served, and in this they largely share a strong view that the stadium will be of real benefit. They also have thought about practical matters about management, access and the effect of the facility on the community and its residents.

4 Detailed Responses to Open-Ended Questions²

4.1 What changes would you like to see to the VHS Memorial Stadium?

As the City has grown, more pressure has been applied on a static inventory of recreational facilities. The Turf field and track would provide multiple sports within the schools and the community with a facility capable of enduring our local weather patterns, something the facility does not provide.better seating, artificial turf either on the front or back fields.
- Upgraded seating for viewing and artificial turf
- · upgrades to the field, lighting
- Covered venue for spectators
- field, stands and out-buildings

Additional ideas for improvements

- Create an 8 lane track with a grass infield that could accomodate throwing sectors for Javelin, Discus and Shot Put. Locate Long Jump/Triple Jump and Pole Vault areas on one end of the field, and High Jump on the other end. Alternative is to place the long/triple jump runways and pits in a North/South orientation parallel to the track, either within the field area or adjacent to the track itself (ie on the 'Fairey Tech lands). Develop the artificial surface on a different field if possible. It is possible to locate the turf within the stadium, but provision must be made to locate the throws events elsewhere, either on a grass field on the Fairey Teach lands, or off-site. The track surface can be a less expensive surface (see http://www.beynonsports.com/en/Products-Track-And-Field-Surface/BSS-100-Running-Track-And-Field-Surface for reference) but should be 8 lanes if the desire is to host local or regional meets. An IAAF certified track is not required but it should meet IAAF standards for an 8 lane track. The difference is largely in the quality of material used for the surface.
- Good quality lights for night use, good quality turf field for winter use, fence openings for easy access by the parking lots and the sides of the bleachers, new bleachers, perhaps a water fountain
- Construction of a new lit artificial turf field would be a big plus for the school and local community. A separate field house would also be of benefit to users of the field.

- All weather turf multi-sport field Some kind of track around field. Not sure if full
 8 lane track is too expensive and won't be fully utilized
- night lights, comfortable seating, chip trail at perimeter, sound system
- New Track. All weather field. Lighting. New seating. New clubhouse and change rooms.
 Coaching and referee meeting room. Bathrooms. Concession area
- Include a multi-purpose grass field to the west which could have space for Athletics
 throwing events (Javelin, Discus, Shot Put) as well as be a great community resource for
 recreation programming through the City and the Fernwood Community Association.
 Include enough space within the track design to include proper IAAF spaces for High
 Jump, Long/Triple Jump and Pole Vault. Include a multi-purpose room within the
 proposed fieldhouse for storage of various community groups equipment (eg Bays United
 FC, Pacific Athletics Track and Field Club) and also serve as a small indoor training area
 for inclement weather.
- The upgrading or inclusion of track and field facilities, for example: long jump pit, triple
 jump, high jump area, shot put cage, even hammer throw (very few facilities in town for
 this). I think this would allow for track and field meets to be hosted by the school and
 allow for PE classes to incorporate T & F into the curriculum. This may allow for more
 rentals for the school and also allow the possibility for future sport academy's.

Issues related to access and user groups

- none, its fine the way it is
- less expensive project
- While it isn't in great shape, I don't think that changes to the stadium are a priority to a school with so many other diverse needs, such as school supplies and food.
- Im not sure wither a stadium should be your set focus maybe the old textbooks buying new ones or cleaning the cancer causing fungus in the hallways

Concerns about personal security

- The priority should be placed on lights and turf to make the maximum impact on the sport.
 I also like the discussions of making the paths and corridors safer for women at night by lighting up and removing obstacles to the light.
- Secure seating to discourage garbage and debris
- lights for night use, a cushioned jogging track around the perimeter, stadium seating with clearly visible space behind for security (no hiding there)

Maintaining tradition

- Modernization. Whilst keeping aspects of the stadiums history.
- · Perhaps highlight the history with a bigger and better plaque.

Other comments

- Build a turf pitch without fencing as fences are hardly part of the spirit of Fernwood.
- While I support the stadium upgrades, as a very close neighbour I am concerned about light pollution and removal of open green space.
- Raked seating, accessible seating, artificial field, appropriate lighting- not too bright.

4.2 What changes would you NOT like to see to the VHS Memorial Stadium?

General support

- All of the proposed upgrades looked like good improvements.
- Nothing....pls do it now!
- None
- None

Nothing, any upgrade is a positive for the community.

Specific issues related to stadium form

- · I would NOT like to see artificial turf
- Please, please, please do not construct anything less than 8 lanes for the track. Smaller tracks (4 or 6 lanes) cannot host any school meets and there are always conflicts with joggers versus track runners simply because there are two few lanes. With 8 lanes you can always allow 2 lanes to be open (e.g. 7 and 8 on the outside) while allowing a buffer zone of 2 lanes, then leave 4 lanes available for track training. This is safer and allows for both user groups to occupy the track at the same time.
- · Keep the track if possible.
- I would want to ensure phase1 includes the turf field, so that shouldn't be changed.
- Artificial turf offers no benefit to the school, lighting will create light pollution
- Do not make it less than 8 lanes as a track. You cannot hold officially sanctioned track and field competitions on anything less than an 8 lane track.
- I would like to see facilities that events can be held. please don't limit facilities so that events can't be held because they are too small.
- I don't want to see a ton of money spent. Just a well built track and field with some good seating with no bells and whistles.
- No all-weather fields. These offer a lesser experience and cause injuries.

Cautions on neighbourhood impact

- The overall size and appearance should be in keeping with the low key, community feel of the area and not be large and imposing.
- The current proposal is good in that it doesn't propose vastly increased seating to
 accommodate larger functions that would likely have a negative impact on the
 surrounding community. The current seating plans are sufficient to ensure the hosting of
 school and local amateur sporting events. Temporary seating additions for events such
 as BC High School Championship events or Greater Victoria School events would be
 acceptable, just not a vast increase to permanent stands for seating.
- excessive fencing
- Covered seating or players areas.... will attract the homeless and afterhours issues.
- · Logos and advertising from sponsors in the stadium. Over extension of parking
- Any tall structure
- Over-lighting. Constant use by community groups would stress neighbourhood.

Concerns about alternative priorities for the school

- An extremely expensive project that is of little use to a school that focuses on the arts.
- That it not be the #1 priority for alumni and funds raised. That the school and classrooms be the #1 priority.

Issues related to access and user groups

- Not to be used for only school purposes
- restricted usage
- It not just becoming a sports field for elite sports organizations.
- Use that is restricted to SD61 only.
- I come from the perspective of the Fernwood Football Association. We are a local football club, around a decade old who've been an important part of the community. I would not like to see Bays United gain a monopoly on the evening and weekend playing field time.
- Dog park
- Would not like a closed/locked facility
- Not having access evenings and weekends for jogging

General opposition

- · Just don't do the stadium.
- Don't change it ok
- Leave as is
- Its fine how it is

Other Issues

- I believe elements for the historic stadium should be restored. Pay homage to its rich history but create a modern sports facility for the students and supporting communities
- Don't paint the bleachers pink.
- The "memorial stadium" on the front of the seats
- Removal of old stadium just repairs and additions only
- part of the charm of vic high is the history. I graduated in 90 and played on the soccer and field hockey teams. Would be disappointed if the new structures were so modern that they would take away from the "old school" charm of vic high
- the stands that are already there, they were donated by another class in memory to lost students, do they need to be replaced due to safety concerns or could you not work with what is already there.
- Becoming a rental stadium......to go after income.
- Would like to keep as much green space as possible and replace all trees with new ones.
- Tearing down of the present bleachers.
- · Too modern of a style
- Prefer not to have corporate sponsors advertising
- Massive and/or too modern. This would be an insult to the beauty and heritage of our building. I think the design should fit in with our current building.

4.3 How can community use of any new sports facilities be accommodated?

Good management of facility

- Great idea but without the proper controls this will be a project that starts off great and in a few years will be a disappointment and an eyesore that we will have to throw money at to repair.
- Reservations for non-school time use via central booking volunteer.
- Work with the Fernwood clubs and user groups in the community to find times to share the benefit of this great project
- Community use is only going to work if it is regulated. The field and track will have to be rented to pay for proper maintenance. The Facility will have to be properly fenced to maintain the condition of the Facility unless the School District and the city put up more funds to maintain and police the Facility properly, otherwise it will deteriorate and become nothing more than a hang out for troubled youth and addiction related problems, as some have already become.
- With funding contributions and field usage agreements.
- · Scheduling and partnership with established community based sporting and other groups.
- Fernwood Football Club could act as a liaison to the community by organizing programs in collaboration with the Fernwood community centre. One idea is an official drop-in soccer program, another is an ongoing yearly affordable kids soccer summer camp. Lastly, since Fernwood Football club has high level soccer teams, the fans of the teams could enjoy supporting their favourite club on weekend games; which would be great in turn for the local businesses and services.
- With a suitable mulit-user agreement. Preferably the City would enforce a multi-use agreement through its Recreation department, with the school board would be the agency

- for school times (eg 8 to 5 Mon-Fri). Bookings outside of school times would be handled by the City's recreation staff.
- Joint use agreement with the City of Victoria. Have them manage the programming during after school hours.
- Other schools, colleges, universities have approaches that could be used or adapted by Vic High.
- Through reservations with the school or school board office.
- I would think there would need to be a permit/registration system with organizations that help fund the facility greeting priority. For example schools and soccer clubs.
- Interested groups can provide input to the planning process and if possible, contribute funding for its development. The facilities once built can be rented from SD61 for community use. Priority could be given to groups involved in the facility development process.
- with well-organized scheduling, and a rental fee payable to the district, of course, to help offset the cost of the facility
- Via a booking/permit system through, for the City of Victoria Recreation department for out-of school hours. For example, if a joint use agreement stipulates the school gets use from 8 am to 5 pm Monday through Friday, then all other booking requests should go through the City. Groups that get behind and contribute to the fundraising, such as Bays United and Pacific Athletics Track and Field Cub may be accommodated with some usage times within the agreement as negotiated by those respective non-profit sports groups.
- post bookings schedules prominently at entry points that clearly highlights when the field is booked. Policy should dictate ratio for School / community sports organizations and school use.
- A part time facilitator could be named, name and number published, so that bookings could be made for available times, to include a fee rate schedule.

 offering a badly needed new artificial turf field for multiple sports and an updated track for
 athletics.
- A lighted facility will offer extended times to rent the facility to outside interest groups.
- After hours when school is not in session. It must be open to everyone unless it is booked for a specific event, and specify how much field time is for the use of the community.
- Out of school hours, as seems to be the case with facilities in other schools; UVIC soccer and field hockey fields may be one model to examine.
- kids soccer evenings and weekends would be welcome.
- School gets first priority
